Performance & Product Certification:

- a) The prospective bidder should be a registered company/ firm including manufacturers or their authorized dealers, capable of supplying new Jewel weighing machines, AMC and replacement of its spares/components and should have offered similar services for at least 3 years to Banks/Financial Institutions and should produce a certificate to that effect.
- b) The bidder should have the following product certification and other criteria:-
 - Product Certification: The products of the bidder must have certification of quality given by the ISO 9001/BIS standard, Dealer certificate etc., and acceptable to Bank.
 - The products must be stamped under Section 23 of the Legal Metrology Act, 2009.
 - Documents of Manufacturing license/ Registration of the OEM factory need to be submitted for verification.
 - Product Certification copies to be attached as per the BIS specifications.
 - The firm should produce authorization from OEM for the products offered in original.
 - Serial number & IS certificate of products are to be provided by the OEM.
 - Audit for Banks, whether actual material is provided or not, needs to be done by OEM as and when required by Bank without any additional cost.
 - Past Record: The bidder or their entities should not have been blacklisted by any PSU/PSB/Government Organization in the past 3 years and undertaking in this regard to be submitted.
 - The bidder's bank account should not be classified as NPA by any Bank. A self-declaration in this regard is to be submitted by bidder as per Annexure 1.
 - The Bidder should submit the details of documents as per Annexure 2.

Payment terms:

- a) No advance payment shall be made by the Bank against purchase order.
- b) Payments shall be made after delivery & installation of Jewel weighing machine at per site basis. The payment shall be made against delivery challan, invoices and commissioning report duly signed by the Branch Manager.
- c) The bidder must be able to visit all the Branches under AMC in every quarter without fail. Otherwise, payment will be forfeited.
- d) AMC, installation & replacement of new spares assigned to the bidder will be monitored/supervised by the Regional Office concerned and the bills will be settled at Head Office on quarterly basis against submission of bills before 10th of succeeding month of previous quarter along with delivery challan, invoices, commissioning report, service report and Regional Office sanction order.



- e) The bidder to be empanelled should have a Bank Account with Tamil Nadu Grama Bank for operational convenience.
- f) Payments will be made by Head Office only.
- g) All other terms and conditions are spelt out in the Terms and Conditions attached to this tender.

Terms and conditions:

- a) Tamil Nadu Grama Bank's Right to Accept/ Reject any/or all Applications: Tamil Nadu Grama Bank reserves the right to accept/ reject any or all applications and to annul the rate contract process and accept/ reject all applications at any time prior to TENDER process or any time after TENDER process, without thereby incurring any liability to the affected bidder or any obligation to inform the affected bidder of the grounds for Tamil Nadu Grama Bank's action.
- b) Tamil Nadu Grama Bank's Right to Split the Service Area Work: Tamil Nadu Grama Bank reserves the right to split and distribute the work among the participating bidders partly or fully amongst the bidders agreeing at lowest quoted rates. Tamil Nadu Grama Bank reserves the Right to Issue Clarifications, Addendums, and Corrigenda etc.
- c) An undertaking that the firm is capable of undertaking installation, repair and maintenance of Jewel weighing machine (including maintenance of existing Jewel weighing machine) in rural and far away areas, where majority of Bank's branches are located is to be submitted by the prospective vendor as per **Annexure 3**.
- d) Vendors having near relatives in Tamil Nadu Grama Bank may not be considered for AMC. Near relative shall mean spouse, father (including step father), Mother (including step mother), Son (including step son) and / or his wife, grandson, daughter (including step daughter) and/or her husband, brother (including step brother) and/or his wife, sister and/or her husband, Father-in-law, Mother-in-law, Brother-in-law and / or his wife, Sister-in-law and/or his husband. A declaration to this effect should be submitted by the applicant as per **Annexure -4.**
- e) Discrepancies or omissions, if found by any bidder, in the terms & conditions of the tender document, or if any clarification is sought by the bidder, a written request, to the application inviting authority, for correction / clarification or interpretation can be submitted up to 5.00PM, 20 Sep 2023 at ped@tngb.co.in. The same will be published in the Bank's website.
- f) Quotation should be submitted as per Annexure -5.
- g) The bidder should able to extend their work in Tamil Nadu Grama Bank's existing 656 branches and proposed new branches spreading all over Tamil Nadu. Successful bidder should have their Support Office set-up at their respective area of operation within 15 days. A declaration to this effect should be submitted by the Bidder as per Annexure -6.
- h) If any deviations are found in the services comparing to our specifications and requirement, Bank will cancel the order and the vendor will be blacklisted.



- i) The bidder should ensure that the defects reported in the Jewel weighing machine or its components supplied to the Bank on any working day is set right within one day. The defect will be reported by the Branch directly to bidder, may be in the form of oral, telephone, notice, email, or any other means of communication. The bidder shall generate a complaint number for tracking the complaint status. In case, the system or any equipment cannot be repaired within the stipulated period, the bidder should provide a replacement till the system/ equipment is returned duly repaired.
- j) The bidder shall maintain the data sheet of Jewel weighing machine of each Branch with details, such as manufacturing date, date of installation, warranty valid up to, AMC carried out on, AMC due on, etc. A copy of the Branch wise data sheet of Jewel weighing machine (including maintenance of Jewel weighing machine) is to be provided to the Head Office/Regional Office as well as to the Branch concerned.
- k) The bidder must ensure quarterly AMC visits. There should be a gap of minimum 45 days between two AMC visits. During AMC visit all preventive maintenance activities to be carried out and recorded.
- The bidder should be capable of offering Annual Maintenance Contract (Comprehensive or Non Comprehensive) for at least 03 years, post completion of warranty. However, awarding of AMC is fully under the discretion of Bank.
- m) Quotation should be submitted on or before 25.09.2023 @ 3.00 PM.
- n) The rate quotes should be inclusive of Transportation, Loading & Unloading charges (To be installed/replaced at respective Branches).
- o) Earnest Money Deposit (EMD) Rs.10,000/- should be remitted through NEFT to our bank account No. 10158768274; IFSC: IDIB0PLB001 ('0' Stands for Zero) (OR) Remittance of EMD through Demand Draft in favour of "Tamil Nadu Grama Bank" payable at Salem.
- p) EMD details should be submitted along with quotations as per **Annexure -7** attached herewith, failing which the quotations will be summarily rejected.
- g) EMD amount will be returned to all the unsuccessful bidders.
- r) EMD amount will be paid to the successful L1 bidder at the time of final payment.
- s) If the L1 bidder does not execute the supply/work order or supplied with any deviations in specifications mentioned in the supply/work order, Bank will cancel the supply/work order and EMD amount will be forfeited.
- t) "Bid Security Declaration" will not be accepted.
- u) The successful Bidders/ Firms/ Vendors will remain in the list of the Bank for two years from the date of contract or till the completion of next contract period at the Bank's discretion (whichever is earlier).
 - The Rate Contract will be valid for (02) two years. Initially work will be allotted for one year (1) and will be renewed on yearly basis up to one more year. On successful completion of first year, renewal for second year will be subject to the satisfactory performance and review by Department concerned. Revision of rates during the contract period will not be entertained by Bank for whatsoever reasons.
 - Contract will be valid only, if all eligibility criteria mentioned in the Tender Notice are fulfilled during the entire contract period.



- If the service provided by bidder is found to be poor and unsatisfactory or if at any
 point of time during the Tender process it is found that the information provided by
 bidder is false, the Bank reserves the right to cancel the contract. Bank's decision
 in this regard will be final.
- v) **Termination for default:** The Bank, without prejudice to any other remedy for breach of Contract, by written notice of default sent to the Bidder, may terminate this Contract in whole or in part:
 - If the Bidder fails to deliver any or all of the services within the period(s) specified in the Purchase Order.
 - If the Bidder fails to perform any other obligations(s) under the Contract. In the
 event of the Bank terminating the contract in whole or in part, the Bank may
 procure, upon such terms and in such manner, as it deems appropriate, the related
 services, similar to those undelivered, and the Bidder shall be liable to the Bank
 for any excess costs for such similar services. However, the Bidder shall continue
 the performance of the contract to the extent not terminated.
- w) Force Majeure: The Bidder shall not be liable for penalty or termination for default if and to the extent that the delay in performance or other failure to perform its obligations under the Contract is the result of an event of Force Majeure. For purposes of this clause, "Force Majeure" means an event beyond the control of the Bidder and not involving the Bidder's fault or negligence and not foreseeable. Such events may include, but are not restricted to, wars or revolutions, fires, floods and epidemics.

If a Force Majeure situation arises, the Bidder shall promptly notify the Bank in writing of such condition and the cause thereof. Unless otherwise directed by the Bank in writing, the Bidder shall continue to perform its obligations under the Contract as far as is reasonably practical, and shall seek all reasonable alternative means of performance not prevented by the Force Majeure event.

Similarly, Bank shall also be not liable for any delay or failure in providing required infrastructure or support to the bidder to perform its obligations under the contract where such delay or failure is the result of an event of Force Majeure. For purposes of this clause, "Force Majeure" means an event beyond the control of the Bank and not involving the Bank's fault or negligence and not foreseeable. Such events may include, but are not restricted to, wars or revolutions, fires, floods and epidemics.

- x) Copy Right/Licence Violation: The bidder shall explicitly absolve the Bank of any responsibility/liability for use of jewel weighing machine delivered by the bidder (i.e. the bidder shall absolve the bank in all cases of possible litigation/claims arising out of any copy right/license violation.) for jewel weighing machine(s) sourced either from third parties or from themselves.
- y) Responsibility for fault free operation: The Successful Bidder, following the execution of the Contract, will assume total responsibility for the fault-free operation of the jewel weighing machine(s) supplied by the bidder during the contract period.
- z) Indemnity: If at the time of supplying, installing / commissioning any jewel weighing machine(s) in terms of contract / order or subsequently it appears at any point of time that an infringement has occurred of any patents, trademarks or other rights claimed by any third party, then in respect of all costs, charges, expenses, losses and other damages which the Bank may suffer on account of such claim, the supplier shall indemnify the Bank and keep indemnified in that behalf.

- aa) **Subcontracting:** The bidder shall not without the prior written consent of Bank subcontract or permit anyone other than the prime vendor personnel to perform any of the work, services or other performance required of the vendor under this agreement.
- bb) The Bidder's performance on the job will be constantly monitored for quality, adherence to the Safety Regulations, Labour / Statutory Regulations, Conduct / Discipline etc, while executing jobs. Any deviations from stated conditions can lead to appropriate deterrent action as deemed fit by Tamil Nadu Grama Bank.
 - Tamil Nadu Grama Bank reserves the exclusive right and absolute discretion to call for tenders for any job or otherwise as deemed fit from open market, even during the validity of the rate contract period.
 - Successful rate contract by Tamil Nadu Grama Bank is no guarantee of any future award of work or inclusion on a particular tender list.
- cc) Resolution of Disputes: All disputes or differences whatsoever arising between the parties out of or in relation to the construction/ meaning and operation or effect of this Rate Contract document or breach thereof shall be settled amicably. If, however, the parties are not able to solve it amicably the same shall be settled by arbitration in accordance with the Arbitration and Conciliation Act 1996 (with latest amendments) and the award made in pursuance thereof shall be binding on the parties. The Arbitrator/Arbitrators shall give a reasoned award. Any appeal will be subject to exclusive jurisdiction of courts at Salem, Tamil Nadu.
- dd) Any delay in completion of the work over the stipulated period will attract penalty of 0.5% of the contract value (site Basis) per week subject to maximum of 10% of the contract value. The Bank reserves its right to recover this amount by any mode, which includes adjusting from any payment to be made by the Bank to the Vendor.
- ee) Bank reserves the right to reject an offer under any of the following circumstances:
 - Incomplete offer and/or all documents not attached.
 - Offer is not in conformity with the terms and conditions stipulated in this document.
 - · Specifications stipulated are not met with.
 - If quotations are not submitted in sealed envelope separately.
 - Violates any terms and conditions specified.
 - If found that the information provided in the offer is false.
- ff) **Termination for insolvency:** The Bank may at any time terminate the contract by giving written notice to the Bidder, if the Bidder becomes bankrupt or otherwise insolvent. In this event, termination will be without compensation to the Bidder, provided that such termination will not prejudice or affect any right of action or remedy, which has accrued or will accrue thereafter to the Bank.
- gg) **Termination for convenience:** The Bank may terminate the contract in whole or in part, at any time for its convenience by giving 30 (Thirty) days' notice. The notice of termination shall specify that the termination is for Bank's convenience, the extent to which the performance of the service provider/vendor under the contract is terminated, and the date upon which such termination becomes effective. Upon expiry / Termination of the Contract, Vendor shall be responsible to provide a smooth transition plan including all efforts for transfer/assignment of service contracts for uninterrupted continuation of services contemplated under this Contract.



- hh) The offer must include on-site warranty of at least one year or as offered by the OEM but not less than one year from the date of installation and replacement of components however there should not be any additional cost for the warranty period.
 - Bidder shall be fully responsible for the manufacturer's warranty in respect of proper design, quality and workmanship of all equipment, accessories, etc., covered by the offer.
 - Bidder must warrant all equipment, accessories, spare parts etc, against any manufacturing defects during the warranty period.
 - During the warranty period the bidder shall maintain the equipment and repair / replace all the defective components at the installed site at no additional charge of whatsoever nature to the Bank.
