Engagement of Counsellor for Financial Literacy Centre on Contract basis

Background

Tamil Nadu Grama Bank, Sponsored by Indian Bank was formed on 01-04-2019 by amalgamation of erstwhile Pallavan Grama Bank, & Pandyan Grama Bank with a branch network of 632 Branches. Our Bank is having 28 FLC centres at present.

Out of 28 Centres, we propose to engage one FLC counselor in each of the following district where the position is vacant at present.

Roles and responsibilities

- i) Carry on day to day activities of FLCs as per guidelines of Reserve Bank of India.
- ii) The Counselor should be available at the center on the designated days.
- iii) Should be familiar with the financial products and services of the target groups. (Poor, women, weaker sections, senior citizens, school/college students).
- iv) To arrange gram Sabhas / awareness camps in rural areas
- v) New schemes introduced by the Banks/Government to be popularized among public through workshop/seminar/ Webinars
- vi) Imparting knowledge on various schemes of Govt. of India (like PMJDY, APY, PMSBY, PMJBY and other social security schemes etc.) announced from time to time as per instructions of HO/ ROs / LDMs.
- vii) Other responsibilities specified by the Bank that may deem fit from time to time.

Work experience

- Candidate should have retired on VRS or on attaining superannuation with minimum 20 years of service of which at least 15 years in Officer Cadre.
- He/ She should have worked as officer / BM in a rural branch for at least 3 years

Contract Period and amount

The selected candidate shall be engaged on Contract basis for a period of three years. Renewal of contract may be at Bank's sole discretion in terms of extant policies and rules of the Bank.

The selected FLC counselor will be paid Rs 10,000/- per month at present and subject to revision.

Age Criteria

- Age of the Counsellor shall not be more than 64 years at the time of application, should possess good health.
- Exit age is fixed at 67 years
- Maximum period of engagement is 3 – 5 years as per rules of the Bank.

Application fee

- There is no application fee prescribed.
